



**Game Number 0170  
WILD 10s**

1. The name of Fast Play game number 0170 is “WILD 10s”.
2. Tickets in Fast Play game number 0170 shall sell for ten dollars (\$10) per ticket, unless otherwise adjusted by temporary price reductions or other promotional activities conducted or authorized by the Commission.
3. (a) Each ticket in Fast Play game number 0170 shall contain a total of forty-two (42) play symbols and a total of six (6) prize symbols.  
(b) Each play symbol is represented as follows:

- (c) Each prize symbol is represented as follows:

4. (a) To play a ticket in Fast Play game number 0170, the ticket must be validly purchased from a Hoosier Lottery terminal.  
(b) If three (3) of the play symbols in any individual “GAME” labeled as “GAME 1” through “GAME 6” match three (3) of the play symbols in the area labeled “WINNING NUMBERS”, the ticket may be redeemed for a prize in the amount represented by the prize symbol that is located directly to the right of the

three (3) matching play symbols for that "GAME". Each "GAME" is played separately.

(c) If two (2) play symbols in any individual "GAME" labeled as "GAME 1" through "GAME 6" match two (2) of the play symbols in the area labeled "WINNING NUMBERS" and a "10" (TEN) appears in that same "GAME" with the two (2) matching play symbols, the ticket may be redeemed for a prize two (2) times the amount represented by the prize symbol that is located directly to the right of the two (2) matching play symbols and the "10" (TEN) for that "GAME".

5. Fast Play game number 0170, "WILD 10s," is not cancellable once printed.

6. (a) The odds for each prize level are as follows:

7. For a Fast Play ticket to be validated, all of the following must be met:

- (1) The ticket must be printed on paper stock which was validly issued to and used by the terminal from which the ticket was printed at the time of purchase;
- (2) The ticket has not been altered, torn, misprinted, found to be illegible, defaced, or damaged in such a manner that validation is impossible;
- (3) The ticket is not counterfeit in whole or in part;
- (4) The ticket has not been reconstituted or tampered with in any manner;
- (5) The typeface and artwork of play symbols, captions, or characters used as

play selections must correspond with the typeface and artwork of play symbols or characters established by the Commission in these approved Game Rules, working papers, or other specifications applicable to the play of game number 0170;

(6) Each play symbol or character must be present in its entirety and fully legible or the ticket must be capable of being validated via the ticket barcode or transaction number as printed on the ticket; and

(7) The ticket must pass any additional validation test prescribed by the Commission, which for security reasons may be confidential in nature.

8. Fast Play game 0170 has a "JACKPOT" prize. Ten percent (10%) of each ticket sold funds the "JACKPOT" which starts at thirty thousand dollars (\$30,000) and grows with each "WILD 10s" ticket sold. "JACKPOT" prize winning tickets for Fast Play "WILD 10s" game number 0170 will be awarded the total "JACKPOT".

9. Tickets for Fast Play game number 0170 are drawn from a constantly replenished statewide pool of winning and non-winning outcomes based on the established odds. When an outcome, winning or non-winning, is randomly selected from the pool, it is then immediately replaced so the pool size and chance to win each prize remains the same for each ticket.

10. Tickets expire 180 days from date of purchase and cannot be redeemed after this date.
